Monitor Shareholding: The members who prepared this voting intention have shareholdings in this company.

The Wesfarmers AGM was completely uneventful this year. 2024 marks the 40th anniversary of the listing of Wesfarmers on the ASX having previously been a farmer's co-operative. It also marks the 30th anniversary of the opening of the first large format Bunnings warehouse in Sunshine, Victoria in 1994. The chairman gives details of the excellent growth of a foundation investment in WES in his address below. There were few questions to the chairman. ASA asked if the dividend payment date could be advanced from October into September. In reply we heard that in order to protect sharholders from market volatility the DRP pricing period runs for 15 days and WES is reluctant to change it as it also gives them time to purchase shares on market to satisfy the DRP. They do not have a need to issue new shares at present.

The CEO replied to a question about our restrictive retail trading hours here in WA with some examples. Bunnings is restricted in the hours it is allowed to sell pet food so it chooses not to sell that range in WA. Also, while they can sell outdoor lighting at any time the sale hours of indoor lighting are restricted! Similarly personal safety equipment does not have trading hour restrictions but there are restrictions on safety boots and overalls so Bunnings dos not sell these items! The CEO pointed out that online sales are unaffected by retail trading hours. Your monitor sometimes thinks that WA is more than 3 hours behind!

In the CEO's presentation he advised the meeting of the trading conditions in the first quarter. Results vary across the divisions. For more information see his speech in the link below.

All resolutions were carried with 96% and over majorities. There were no protest votes on any matters from the proxy advisers.
